

**SCHOOL OF AMERICAN BALLET ENROLLMENT AGREEMENT
2020 SUMMER COURSE**

UPON COMPLETING THE AGREEMENTS AND SIGNATURE PORTIONS OF THE ONLINE INFORMATION UPDATE FORM, I HEREBY AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

1. Tuition Payment and Fees. The standard tuition fee for 2020 is \$3,175. The registration fee is \$75 and the mandatory activities fee is \$150. Please refer to the information provided upon acceptance for payment deadlines. The amount owed may vary depending upon scholarship awards. These fees are not comprehensive and do not cover charges including, but not limited to, off-campus activities, lockers, uniforms, toe shoes, transportation, food, or other personal expenses. I agree to pay all additional fees, charges, or expenses in accordance with the School's requirements, including, but not limited to, all medical expenses or charges related to the Student's care.

2. Obligation to Pay. I am obligated to pay the full tuition, as well as all applicable fees and charges once I have accepted SAB's invitation to attend the Summer Course by submitting the enrollment form. I understand that no portion of the tuition, fees and charges will be refunded or canceled despite the absence, withdrawal, or dismissal of the Student from the School for any reason whatsoever.

3. Right to Terminate Enrollment / Rules and Regulations. I understand that by signing this Agreement, I agree to cooperate fully with the School and to abide by School rules and regulations. I further acknowledge and agree that the Student must abide by the School rules and regulations.

I acknowledge and agree that the School has the right to suspend or terminate the enrollment of any student at any time, or to nullify an enrollment contract at its sole discretion.

4. Student Activities and Authorizations. I agree that the Student has permission: (i) to take part in any and all School activities on or off School property; (ii) to take School-sponsored field trips; (iii) to participate in activities related to the Student's instruction at the School but not sponsored by the School, including without limitation activities with the New York City Ballet; and, (iv) to ride in buses chartered by the School, taxicabs, vehicles driven by employees or representatives of the School, or public transportation. I acknowledge and agree that, notwithstanding the above, I will complete and promptly return to the School any additional permission slips, releases, and/or medical information forms regarding the Student.

I recognize that children may get hurt at School or during ballet training, gymnastic, weight training, Pilates, Physical Therapy and other exercises that may cause unusual stress on the body, and other activities and field trips related to the School. I understand that the ballet and dance training and other School-sponsored activities may cause serious bodily injury.

I understand that the School is not an insurer of the health or safety of the Student, and does not assume responsibility for spontaneous and unforeseen events which may occur during his or her participation in the activities described above. I acknowledge that the Student must strictly adhere to all school rules and instructions during the Student's participation in any of the activities described above.

In consideration of the School's permitting the Student to participate in the activities described above, I hereby, on behalf of myself, my children, spouse, heirs, agents, executors, administrators, and assigns, release and forever discharge the School, its agents, trustees, officers and employees, for any and all demands, claims, damages, actions, and causes of action, pertaining to or arising out of the Student's participation in the above described activities, including but not limited to, claims for negligence, personal injury, breach of contract, or breach of warranty, except in the event of gross negligence or willful misconduct. I understand that as a result of my executing this Agreement, I will be forever barred from suing the School as a result of the Student's participation in the activities described above.

5. Medical Form. I agree to submit the Medical Form applicable to the Student. This Agreement will not be deemed accepted by SAB unless the Medical Form is completed in full.

I agree to permit the School and its designees to use the photographic likeness, video and television recordings, artistic, musical, and written work (the "Likeness and Work") of the Student for School purposes. I knowingly and voluntarily agree to hold harmless the School regarding the reproduction, publication, or other use of the Student's Likeness and Work, and further acknowledge and agree that by signing this Agreement, I waive any claim or cause of action I otherwise might have against the School regarding such usage or damages resulting therefrom.

7. Acceptance of Contract. I acknowledge that the submission of my digital signature on the Information Update Form indicates that I have read this agreement and agree to all terms and conditions.
